### MEETING FOR WORKSHOP WITH ATTENTION TO BUSINESS MINUTES

SIXTH DAY OF THE ELEVENTH MONTH, 2011

Present were: Elise A. (Clerk), Phyllis S. (Recording Clerk), and 33 other Friends and attenders. Our Meeting began with centering worship.

Change of Date - The January 2012 Meeting for Business will be held on January 8, rather than January 1.

ACTION: Meeting was in unity for this change in meeting dates.

Treasurer's Report (Joel R. reporting): AFM is currently in a very good financial position. AFM has paid all of the expenses for researching the potential Lawrence Avenue land purchase, from which we have withdrawn. Several Friend stated that the Meeting may keep the money they contributed towards the Lawrence Avenue land purchase and use the money as the Meeting sees fit. This has contributed towards the strong financial position we are in. In addition, unrestricted contributions total \$36,253. Rentals are \$18,348. Committees continue to be very frugal with their spending. Copies of the Financial Report are attached in the book of Minutes for Meeting for Business.

Stewardship and Finance (Mary K. reporting the second reading of the 2012 budget): S&F presented the first review of the balanced budget proposed for 2012. This budget was circulated via the

announce list earlier in the week. Of note: because we have the Committee Contingency Fund available, we trimmed speaker expenses from committees that have not used their speaker expense line in recent years; all restricted funds goals are met, including the \$10,000 annual contribution (goal) to the Building Fund; and, recognizing Meeting's enthusiastic support when needs are made known, Unrestricted Contributions were raised to meet these goals. A short discussion followed. Further discussion was held over until next week's Threshing Session.

S&F will sponsor a Threshing Session during Meeting for Learning at 9 a.m. next week First Day (the 13th). In this Threshing Session we will consider our previous commitment to the Building Fund and its impact on our budget/expected contributions, as well as strategies to bring the Meeting's financial needs to Friends' minds in ways appropriate to our Quaker heritage. Stewardship and Finance committee invites and encourages all Friends and Attenders to join us so that as many voices as possible can be considered as we move forward. Friends who are unable to make the Threshing Session are strongly encouraged to contribute questions, concerns, and suggestions via email.

Finally, Nominating Committee supports Karen C. transitioning in as Clerk of Stewardship and Finance prior to the end of the year because the current clerk is experiencing health challenges.

**ACTION:** Friends are in unity about the transition of Karen C. as Clerk of Stewardship and Finance prior to the end of the year. Friends greatly appreciate Mary's work as Clerk of S&F and hold her in the light.

Meetinghouse and Lands: Bill K. read notice of our official withdrawal from the purchase of the North Lawrence Avenue property. The contract is now null and void, and our deposit has been refunded. Documentation is attached.

Cleanup day started with the 19 members and attenders assisting out in the cold - the largest number of helpers in recent memory. Because of renters, our work was all outside. We ate inside, due to the painting of the picnic table.

Friends appreciate the previous diligent work of Cairn K., Mary K., and Careen M. with the outdoor plantings.

Nominating Committee (Barbara T. reporting the draft 2012 slate): AFM Nominating Committee presented a draft slate of officers and committee members for 2012 for the first reading. This year's Nominating Committee members are Lee L., Phil F., Cairn K., Margaret H., and Barbara T. The slate has also been circulated on the "announce" list. Although most committees look healthy, additional members would be welcome on all committees with the particular need for Stewardship and Finance, CREC, Hospitality, and Pastoral Care, in addition to representatives to various Friends-related organizations and the position of Assistant Treasurer.

Friends were asked to study the list and provide changes or additions to Barbara T., clerk of Nominating. The improved slate will be presented for its second reading at Meeting for Worship with Attention to Business on December 4. Descriptions of many committees were sent out via email and will be attached to the bulletin board.

A F(f)riend noted that the cuts in CREC's budget for the coming year, and its status as one of the underserved committees, are not unrelated. The fewer people on the committee, the less we are able to consider the long-term goals of making our children a priority at the Meeting as we are so taken up with the need to provide weekly programming for FDS. I would ask that, when Friends consider their leadings to participate in particular committees, they consider also the importance of CREC to the future of AFM as a whole. As Quakers, we have a peculiar responsibility to show our children that they not only will become integral members of the Meeting, but that they already are so. Working with our children does not require that we have children in our own, immediate lives. Nothing can help our children better understand what it is to learn to follow one's conscience, discern a true leading, and live all the possibilities of a Quaker life than having the opportunity to interact in a sustained way with as many of the adults in the Meeting as possible. And when those adults express a genuine interest in, and care for our children, the effects may stretch into the future in ways that far surpass our own imagining.

Ministry and Worship: Tricia R. reported the request of Sam S. for membership in AFM. He requests the continued support and fellowship of AFM as he leaves for his work in the Middle East. M&W plans to bring forth a formal request to affirm his membership in December.

CREC (Joanna T. reporting this Homeschooling report): AFM is pleased to enter the 2011-2012 academic year serving as an umbrella organization for two families. Both families are continuing with AFM, after successfully completing the 2010-2011 year under our care. The families represent three elementary-level, home-school children. We continue to welcome and consider the participation of additional families but recognize that a successful umbrella relationship is founded on comfort, mutual respect, and compatibility. It is important that each family find the right fit for its needs.

BYM Interim Meeting Report is held over to next month.

Closing: These minutes were read and approved during Meeting for Worship with Attention to Business. Meeting closed with silent worship.

## **THINKING ABOUT RACE: "WHAT IS ACCOUNTABILITY?"**

"Participating in solidarity work implies that I am not from the community in which I am working, that I have skills or privilege to offer, and that I am constantly and consciously working towards developing others' leadership and access to resources. This process includes political advocacy, building valuable relationships, reallocating resources, being transparent in my actions, and being strategic and sustainable with my energy. The key word - *accountability* - means recognizing that this work is about supporting folks and their projects [in that community] in a way that is not about me and my involvement, but is about the people directly affected and the way they wish to express their needs and greatest potential."

## **LIBRARY CORNER**

"Flunking Sainthood: A Year of Breaking the Sabbath, Forgetting to Pray, and Still Loving My Neighbor" by Jana Reiss

ATTENTION: The AFM library has many new books found on the counter in the right side of the book rack. Come see what might appeal to you. We are always open to ideas of other books you might recommend.

One of the new books is "Flunking Sainthood." The author, Jana Riess, decided to try to follow 11 disciplines, practicing one each month. The first month she spent figuring out which ones she would do. The topics included everything from fasting to Benedictine hospitality.

Her thinking at the beginning was "how hard can this be" concentrating on only one a month. At year's end she was discouraged, thinking she had failed. Her editor encouraged her to write a book about "the wild acceptability of failure." It is written at a human level, giving insight into her problems and failures. Even though she didn't accomplish what she set out to do, the learning along the way was educational to her.

While this book is not deeply religious, it does give the reader pause to reflect on ways to make our lives more spiritual. It is a comfortable and easy read. While I didn't laugh out loud like some of the reviews indicated it is amusing in some areas. The quotes she adds are very meaningful and appropriate to the subjects. She gives name of books of the authors she has quoted for additional reading. It is a light spiritual read.
