Meeting Minutes - Approved

9:00 am Opening: We began with centering silent worship. The clerk welcomed all in attendance. The $12^{\text {th }}$ Month Queries from Baltimore Yearly Meeting Faith and Practice (revised 2001) were displayed on the screen. The clerk read the names of all in attendance.

The AFM Anti-Racism Queries were read aloud for those on the phone, reminding us all about our commitment to make decisions based on these commitments. The agenda was displayed for today's meeting.

## Agenda:

1. $11^{\text {th }}$ Month MfW wAtB Meeting Minutes Review \& Approve:
a. The meeting minutes were approved from the previous meeting held on $11 / 01 / 2020$. See the attached. The minutes were sent prior to today's meeting via email and were displayed on screen for final review. The minutes were approved.
2. Ministry \& Worship (M\&W):
a. On behalf of the M\&W, Tom W. joyously welcomed Ann R. who has requested that her membership be transferred from Chapel Hill Monthly Meeting to Annapolis Friends Meeting. Ann was described as a most faithful Friend and the Meeting enthusiastically embraced Ann who said that after 26years of sojourning, she was happily transferring her membership and plans to be buried in Annapolis when that time comes.
b. Changes to MfW times were requested, including:
i. December 20th, CREC requested to end the 11:00 am Zoom MfW at 11:45 am, so that the children can present their annual holiday presentation.
3. The request was approved and it was noted that the children made a request last year that the adults also participate in the holiday presentation. Tom W. will coordinate any adults who would like to join in.
ii. December 24 ${ }^{\text {th }}$, M\&W requested that the Christmas Eve gathering be held on Zoom at 7:00 pm and the request was approved. Tom W . will be organizing the gathering that is likely to include music, singing and candlelight. More information will be sent to the AFM-Announce email list.
iii. February $7^{\text {th }}$, M\&W requested that the Spiritual State of the Meeting Listening Session be conducted during the 11:00 am Zoom MfW. The request was approved.
4. Children's Religious Education Committee (CREC):
a. During First Day School (FDS) last First day, the children entered into their discernment process with regards to their portion of funds that would come from the AFM Quaker Spring and Holiday Markets.
b. The children participated in both the Quaker Spring and Holiday Markets by assembling jars of 13-Bean soup to be sold at the Quaker Holiday Market. On behalf of FDS, Ceili M. read the minute. The $\$ 200$ will be equally divided between four causes, including the Maryland Zoo; My Brother's Pantry; Gay, Lesbian, Straight Education Network (GLSEN); and the Jane Goodall Foundation. The Meeting enthusiastically supported the FDS discernment. It was noted that the treasurers will need to receive an email with the specific information, so that the checks can be written and mailed to each of the organizations. (CK - \$200 from combined Spring \& Holiday markets.
5. Nominating Committee:
a. On behalf of the Nominating Committee, Wes J. expressed gratitude for the committee members who participated and all who took on roles on behalf of the Meeting. Wes announced the 2021 Slate (see attached). He requested final approval of the proposed Slate and received the approval.
i. It was noted that there aren't any clerks for CREC at this time and there is a call for $\mathrm{f} /$ Friends to step forward to assist CREC in whatever way they are led, and to consider clerking.
ii. It was announced that AFM has a new committee, the Communications Committee, that was added to the slate and will be starting up in January 2021.
iii. On behalf of M\&W, Ann R., the incoming clerk, requested that f/Friends be conduits of information and excitement related to other Quaker organizations in the upcoming year, so that we can all sense and feel how interconnected we are with Quakers all over the world. Liaison opportunities are noted on the slate. People were encouraged to let Ann know if interested.
6. Meetinghouse \& Land (MH\&L):
a. On behalf of the MH\&L, Kim F. provided a report with regards to work that the MH\&L committee has accomplished or are in the process of working on, including upgrading the routers for outdoor and indoor internet reception. There is a hope that the internet will be accessible out into the parking lot. MH\&L are investigating how best to improve the ventilation system inside the meetinghouse to make it safer during pandemic times and get ready to have indoor events.
i. A Friend asked about the Chesterton Academy and if they intended to return. It was noted that they did find an alternative location and that Chesterton Academy have not approached us recently. The assumption at this point is that they have secured a location and will not be needing AFM.
ii. There were items of concern that were brought up, but time did not allow for discussion. Although a discussion ensued, it was requested that the discussion be continued outside of this MfW, so that a better understanding of each of these issues can be fully understood prior to bringing these issues to MfW wAtB.
7. There is a longstanding MH\&L concern about the 27-year old cork floor and when it will be replaced. Although repairs were made, the floor needs to be replaced and, with no one in the building, it was suggested that now is a good time to work on the floor.
8. The parking lot was to be converted to a pervious surface and, again, with very little traffic, it was suggested that now would be a good time to get this task completed.
9. It was noted that the gardens and landscaping are in need of attention and very little seems be happening to improve or maintain the grounds. It was noted that there is an inexpensive crew that did a fine job in the past and would love to do the work. A joke was made related to the crew that did landscaping work in the past and there were comments that the joke was offensive and had been made previously as well. There was a request that the joke not be brought up again.
iii. Enlarging the meetinghouse was another concern that was mentioned and a question was posed whether the expansion was still under consideration. Kim responded that this did not seem to be a priority at this time, especially since we are not currently using the meetinghouse.
b. The clerk reminded $\mathrm{f} /$ Friends to have faith that the committees are putting great care into discerning what is best, although f/Friends have opinions and the committees welcome input. We were asked to appreciate all the work that each committee is doing. Several f/Friends expressed specific appreciation for the MH\&L committee and all the fine work they have accomplished this year.
10. Committee Requests (attached):
a. Three committees made requests that were provided in writing with the invitation and announcement of the MfW wAtB. Please see the attached from the following committees:
i. Path Forward Committee: On behalf of the Path Forward Committee, Karen C. asked if Meeting would approve a Spiritual Friendship / Community Group that is conducting hybrid meetings to be allowed to extend into the foyer with open doors and open windows, similar to how MfW groups are practicing. The Meeting was not in unity with this request due to the current rise in numbers associated with new coronavirus cases.
ii. Peace \& Social Concerns (P\&SC): On behalf of P\&SC, Phil C. explained that we previously thought we had an emergency situation with people out of work, hungry and homeless, but that the situation has actually gotten worse in the past eight months and the needs are even greater. The food banks are indicating that their annual demands have tripled. P\&SC is requesting that they take the remaining \$2,839 in Emergent Social Concerns and add their remaining $\$ 300$ from their 2020 budget and donate the funds to the following groups: the Light House Homeless Prevention Center (1/3), the Maryland Food Bank (1/3), the Feed Anne Arundel program that is a countywide collaborative providing meals to those in need (1/6), and to yet-to-be-named South County food program (1/6).
a. The request was approved.
iii. Meetinghouse \& Land (MH\&L):
11. On behalf of MH\&L Committee, Kim F. requested that monies be approved for the purchase of 24 new chairs (mesh, indoor/outdoor, easily sanitized, fold, take up less space, lighter). This was intended to be an expenditure for 2020. The request was approved.
a. A Friend suggested that the discarded chairs be sold and MH\&L will take that suggestion into consideration.
12. Stewardship \& Finance (S\&F):
a. Treasurer's Report (2 attachments)
i. On behalf of the treasurers, Julie R. shared her screen and the Treasurer's report which was also attached to the invitation for the MfW wAtB. It was with joy that Julie reported that Friends were able to share our ample resources with food banks and people who need the funds. There is one month left. For highlights, AFM is on track with other years. The overall deficit as of November $30^{\text {th }}$ is $\$ 4,600$ and we will be able to cover our current expenses with the expected contributions that will be received in December. In addition, we have the committee contingency funds if we need to access that. There were a number of requests from various committees. In some cases, more requests than the funds were available.
ii. A one-time transfer was made from Committee Contingency Fund to the Suffering Fund in November due to an urgent need. This transfer was approved by Clerk of Meeting, Trustees, and Clerk of S\&F.
iii. Meeting approved that five thousand dollars $(\$ 5,000)$ be moved from the Committee Contingency Fund to refill the Suffering Fund account to cover future requests.
iv. There is a narrative report included in the attached Treasurer's Report that provides additional details of the discernments.
b. 2021 Budget Report (see attachment)
i. In general, the committee requests for 2021 funding were too large given the pandemic and uncertainties related to rental. Some requests were reduced to get to a reasonable budget amount, for example. MH\&L. Additionally, the recommendation is to put less money into internal funds from the 2021 operating budget. The goal is to support the operating budget and to contribute additional funds to the Committee Contingency Fund and the Emergent Social Concerns Fund. If there is a surplus in 2020, the plan is to split the funds between the Suffering Fund and the Emergent Social Concerns Fund.
ii. In general, the committee requests for 2021 funding were too large given the pandemic and uncertainties related to rental. Some requests were reduced to get to a reasonable budget amount, for example, MH\&L. The plan is to not put additional money into internal funds. The goal is to support the operating budget, and provide the new committee (Communications) with $\$ 3,000$. If there is a surplus, the plan is to split the funds between the Suffering Fund and the Emergent Concerns fund.
iii. The proposed annual budget for 2021 is $\$ 54,000$, which seems reasonable even if we do not receive any rental income.
iv. Wes J. noted that the rental income is an unknown at this time. The 2021 budget is a "stake in the ground" for today. Next year will proceed as it will and the budget will be adjusted as needed. The Founders fund CD will come available in September 2021 and that option will be evaluated in the future.
13. The clerk indicated that some agenda items would be held over due to the heavy agenda for December and the need to close the meeting, so that worship could begin.

Closing: AFM MfW wAtB was concluded with a brief moment of centering silence. The clerk expressed gratitude for all participants in the meeting. The recording clerk will send the draft meeting minutes to the Announce List, so that Friends can review the draft minutes and provide feedback. The minutes will be brought forth for approval at the beginning of the next MfW wAtB.

## Operating Budget:

The operating budget income is derived from two sources - Unrestricted Contributions and Rental Income. The expenditures are based on the general operating budget (and do not include expenditures from ID funds). Totals effective 12/3:

The contribution numbers are in line with what we had brought in previous years at this point in the year. The rental figures are lower as we have not been renting the Meetinghouse and do not expect additional rentals (or reimbursements) this year (the 5,665 reflects the expected final rental figure for 2020). We have currently spent 4,676 more than we have brought in. This is in line with previous years' spending. As with previous years' spending, we expect that this will be covered with end of year contributions (typically get more than $\$ 10,000$ during December).

A budget of 78,630 has been requested. These is risky given the fact that we cannot count on rental income. Two recommendations for a more realistic budget:
Reduce amount given to ID funds. Use any FY20 surplus to replenish these funds rather than including them in next year's budget.
Suggestion that we move forward with a FY21 contribution of 3 K for committee contigency and 4080 for ESC ( 1080 QC, 3 K other). FY20 surplus to be split between ESC and Suffering Reduce the MH\&L approved budget to around 21 K . Allow MH\&L to detemrine what line items should be adjusted.
This 21 K MH\&L figure is a significant reduction, but still higher than true expenditures from the committee in the past.
These two steps would give us a budget of 53 K which is more reasonable. If way opens, MfB can approve a budget adjustment to increase ID funds later in 2021
